This Addendum is being issued due to a typographical error contained in **Section 4.6 Evaluation and Award of Contract** (page 46 of the RFP). Please note the following corrections/changes to the RFP:

1. Stage 4 Evaluation (page 48) shall now read:

Final scoring for each proposal will be calculated. For this RFP, the evaluation percentages assigned to each section are:

- A. Program Evaluation including responses to Section 2.2.1 Questions, Section 2.4 Customer References and Section 2.5 Personnel Qualifications are worth 60% of the total evaluation score.
- B. System Evaluation including responses to Section 2.2.2 Questions are worth 10% of the total evaluation score.
- C. Fiscal Evaluation, Section 2.3 Questions, Cost Analysis and Project Budget are worth 25% of the total evaluation score.

D. Section 4.6, Stage 3, Other Materials considered is worth 5% of the total evaluation score.

If HCJFS determines that is not necessary to conduct a Stage 3 review, the evaluation percentages assigned to each section are:

- A. Program Evaluation including responses to Section 2.2.1 Questions, Section 2.4 Customer References and Section 2.5 Personnel Qualifications are worth 65% of the total evaluation score.
- B. System Evaluation including responses to Section 2.2.2 Questions are worth 10% of the total evaluation score.
- C. Fiscal Evaluation, Section 2.3 Questions, Cost Analysis and Project Budget are worth 25% of the total evaluation score.
- 2. The deadline date for issuing Addenda has been extended to January 19, 2012.
- 3. The Oral Presentation/Site Visits (if needed) will be scheduled the week of February 13, 2012.
- 4. The deadline date for submission of Proposals has been extended to to January 27, 2012.

Any Provider having already submitted a Proposal may resubmit the Proposal in its entirety by the extended end date of January 27, 2012.

NOTE: Any Provider having already submitted a Proposal may choose to retrieve the previously submitted proposal for modification and resubmittal. If a Provider chooses to submit a modified Proposal without retrieving the originally submitted Proposal, the modified Proposal must be clearly marked as a "Replacement Proposal".
