

# **Frequently Asked Questions**

# Who can apply for a grant?

To be eligible for the FAMILY Fund Grants, you must meet the following criteria:

- Have emancipated (or will emancipate) from Hamilton County, Ohio on or after your 18<sup>th</sup> birthday;
- Have been accepted into or are enrolled in a degree, certificate, or other accredited program at a college or university that provides transferable credits;

OR

Have been accepted into OR are enrolled in an apprenticeship, military, or other job training program that has been preapproved by the FAMILY Fund;

- Have had a JFS Program Specialist (<u>Hamil-TAY@jfs.ohio.gov</u>) confirm your eligibility after you filled out the <u>Educational Funding Inquiry Form</u>;
- Have already applied to FAFSA and Ohio ETV (*if these are applicable to your educational program*);
- Will use awarded funds before you turn 27 years old;
- Have met your institution's requirements for satisfactory academic progress (*applies to students who have started their postsecondary program*).

## What is FAFSA and Ohio ETV?

**Free Application for Federal Student Aid (FAFSA)**: Most schools will require that you fill out the FAFSA to receive need-based financial aid. To find out if you qualify for federal or school-based financial aid via the FAFSA, please contact the financial aid office at your chosen institution.

**Ohio Education and Training Voucher Program (ETV)**: The Ohio ETV program is a federally funded program designed to assist current and former foster youth with postsecondary education expenses.

## How do I apply to FAFSA or the Ohio ETV program?

**Free Application for Federal Student Aid (FAFSA)**: You may fill out the FAFSA application at <u>https://studentaid.gov/h/apply-for-aid/fafsa</u>.

**Ohio Education and Training Voucher Program (ETV)**: To apply (*or find out if you are eligible*) for Ohio ETV funding, please visit <u>https://www.fc2sprograms.org/ohio/</u>. If you have questions regarding the Ohio ETV program, please email <u>oh@statevoucher.org</u>. Some short-term job training programs do not qualify for ETV funding. Even if your short-term training program does

not qualify for ETV funding, you may still apply for a FAMILY Fund grant if the JFS Program Specialist determines that your program is eligible.

## How much money could I be awarded by the FAMILY Fund?

The purpose of our FAMILY Fund grants is to fill postsecondary funding gaps for qualifying students. How much money you may be awarded will depend on your financial need, which FAMILY Fund grant you apply for, and whether House Bill 164 (details below) passes. We offer two types of grants:

- <u>Title IV Grants</u>: This grant can only be applied to postsecondary academic and job training programs that qualify for Title IV federal financial aid such as the Pell grant. Award amounts can vary up to \$5,000. Your award amount depends on your financial need, as well as the responses you provided in the application, and your academic situation. Applicants are eligible for one Title IV grant per calendar year.
- 2. <u>One-Time Grants</u>: Applicants are eligible to receive this grant just one time. Award amounts can vary up to \$2,000 and tend to be under \$500. This grant is primarily for students who have most of their postsecondary academic and job training costs covered but need money to cover one expense, such as a certification fee, to purchase tools, to create a portfolio, or for other expenses that either enhance the student's educational experience or facilitate program engagement and completion. *Title IV grantees may only apply for this grant if they experience a life-altering event, such as a debilitating injury, new child, etc., that dramatically changes their financial need.*

<u>House Bill 164 (HB 164</u>) was recently proposed in the Ohio legislature. *If this bill passes*, a new foster-to-college scholarship program would be set up in Ohio to fund postsecondary financial gaps for qualifying current or former foster youth. Since HB 164 has not yet passed, we do not yet know how it will impact our grant program. You may read more about the bill and follow it using the blue link above. ## Which grant should I apply for?

This depends on your educational program and needs. Please fill out the <u>Education Funding</u> <u>Inquiry Form</u> and a JFS Educational Specialist will work with you to figure out which FAMILY Fund grant, if any, to apply for. The JFS Educational Specialist may direct you to other financial aid resources unrelated to the FAMILY Fund.

### Does my program qualify for Title IV federal financial aid funding?

Your academic institution or job training program will know if your degree or certificate program qualifies for Title IV federal financial aid such as the Pell grant. Please reach out to your institution's financial aid office. Make sure to also ask if you might be eligible for other financial aid and how to apply.

# When should I apply?

This will depend on which grant program students are eligible to apply to.

The Title IV application submission period happens two times during the year (July and November). Students are eligible to receive one Title IV Grant per year and may apply during the submission period that best suits their educational plans. For more guidance on when to apply, see the table below.

\*Some job training programs start on a rolling basis throughout the year.

The FAMILY Fund will accept One-Time Grant applications four times during the year: January, April, July, and October. For more guidance on when to apply, see the table below.

#### How do I get an application for FAMILY Fund grants?

Application materials and instructions on how to apply for the FAMILY Fund grants are provided to eligible students by a JFS Program Specialist. You need to complete the <u>Education Funding</u> <u>Inquiry Form</u> first, then a JFS Program Specialist will reach out to you and let you know about your next steps after this form has been submitted. These specialists are also knowledgeable about other aid sources and can help you with more than just providing the FAMILY Fund application materials.

#### Do I have to pay back the money if I receive an award?

No, the grant you receive does not need to be paid back. However, sometimes your institution may require you to pay back other financial aid you have received when these funds are distributed if your total aid exceeds your cost of attendance. #### How and when will I know whether I received a grant?

You will be contacted via email about three weeks after the application closes. We realize that you may need to make loan decisions prior to this date. If this is the case, please send an email to <a href="https://www.hamil-TAY@jfs.ohio.edu">https://www.hamil-TAY@jfs.ohio.edu</a> so that we can prioritize your application. We also encourage you to talk with the financial aid office at your institution. There is often flexibility around changing loan dates or amounts.

#### Do my grant funds expire?

From the date of your award, you will have two years to use the money you have been awarded so long as you are under age 27. If after two years you have not used all this money or you turn 27, then your money will be returned to the grant fund pool and reallocated.

#### How do I access my awarded funds?

To use awarded funds, students must submit a Request to Utilize Funds form to a JFS Program Specialist at <u>Hamil-TAY@jfs.ohio.edu</u>. Your money cannot be accessed until the form has been filled out and your expenses have been approved. This form will be provided when students are awarded a grant. Students need to allow a couple of weeks for this request to be processed.

#### How do I receive my awarded funds?

All awarded money will be paid directly to the institution or accredited program in which the student is enrolled. If the student's expenditures or fees are not directly billed by the institution, they may be sent to an alternate entity. Your JFS Program Specialist at <u>Hamil-TAY@jfs.ohio.gov</u> can help you through this process.

#### What can I use the grant money to pay for?

Awards can be used for services and supplies that help students to engage in, enhance, or complete their postsecondary education and training program. For example, awarded funds may be used toward a variety of expenses such as tuition, books, school supplies (i.e., pens,

paper, pencils, notebooks, etc.), computers or laptops, lab uniforms, lab supplies, testing fees, licensure, and items needed for technical and vocational programs.

# Can I use my grant money for rent?

Requests to use the award for rent will be reviewed on a case-by-case basis. If you are concerned about your rent, please reach out to a JFS Program Specialist at <u>Hamil-TAY@jfs.ohio.gov</u> to discuss options.
